PH() FAX() _____ HEREBY ENTER INTO THE FOLLOWING CONTRACT FOR THE PROVISION OF TOWING SERVICES AND AGREE AS FOLLOWS:

THE DESCRIPTION AND LOCATION OF THE PROPERTY FROM WHICH VEHICLES WILL BE REMOVED AS: _____ ALL VEHICLES REMOVED WILL BE TOWED AND STORED IN A LOCKED, GATED IMPOUND LOT LOCATED AT 5225 YOUNG PINE RD. ORLANDO, FL 32829.

1. This Contract shall commence on the _____ day of _____, 2007 and shall terminate on _____, **2009** (**must be renewed with city every 2 years, contract may be canceled at anytime with signed notice by "Property Representative" and/or "Towing Service"**).
2. By this Contract, the Property Representative authorizes the Towing Service to remove any unauthorized vehicle, hereinafter referred to as "Trespass Towing", parked on the following property: _____ hereinafter referred to as the Premises.
3. Trespass Towing from the Premises shall be authorized only on the following dates and times:
a) Only on demand of property owner/agent.
4. Any vehicles Trespass Towed from the Premises shall be towed to **5225 YOUNG PINE ROAD, ORLANDO, FL 32829**.
5. Towing is authorized: 7 Days of week, 24 hours a day.
6. Fees charged to a vehicle owner shall be consistent with applicable law, paragraph 10 below. All fees to be charged at vehicle owner's expense and shall be as follows:
\$100.00 for towing (including first 24 hours); \$20.00 per day thereafter; \$50.00 administration fee after 48 hours.
7. The Property Representative affirms that he/she is the owner or the tenant of the Premises or the agent of the owner or tenant and has the authority to enter into this Contract. Any contract with a property owner for towing with a duration period longer than two years, or in the absence of a termination date, shall expire one year to the date it was signed by the Property Representative.
8. Signs will be posted at each entrance to the property and shall state as follows: "TOW AWAY ZONE UNAUTHORIZED VEHICLES & VESSELS WILL BE TOWED AT OWNER'S EXPENSE AIRPORT TOWING 407 275-8721 STRICTLY ENFORCED 24 HRS. A DAY 7 DAYS A WEEK. TOWING IS REGULATED BY CHAPTER 39 ORLANDO CITY CODE AND 715.07 FL. STATUTE VEHICLES WILL BE TOWED BY: AIRPORT TOWING 407-275-8721"
